Social security numbers, driver's license numbers, credit card numbers, electronic mailing addresses, telephone numbers, emergency contact information, any addresses for a unit owner other than as provided to fulfill the association's requirements, and other personal identifying information of any person, excluding the person's name, unit designation, mailing address and property address.

The aforementioned protected information is hereafter referred to as "Protected Personal Identifying Information". I(We) understand that in order for me(us) to have certain information about me(us) published in the Sugar Sands Directory, it may be necessary for the Association to obtain, utilize and publish certain limited Protected Personal Identifying Information, specifically our address and telephone number(s) (land line or cellular) (hereinafter "Contact Information").
